Background


- Some states have expressed interest in submitting 319 watershed based plans (WBPs) as alternatives in the context of the 303d program measure
 - Reporting alternatives approaches under the 303d program measures WQ-27 and WQ-28 is a new concept
- Bridges across 303d and 319 programs at all levels (State, Regional and HQ levels) are valuable to:
 - Make effective use of resources to restore waters,
 - Provide opportunities for program staff learn from one another
 - Highlight best practices

Focus of EPA's review of watershed based plans will differ for NPS and 303d program purposes

Primary role of regional NPS review of WBPs:

 Confirm that the plan meets the 9 minimum elements and is thus eligible for implementation with 319 funding





Plan Designed to Meet Water Quality Standards, in Impaired Waters

Purpose of the 303(d) staff review of WBPs:

whether plan is consistent with the 303d Vision and would be counted under the 303d program measures

303d Vision alternatives

 303d Vision alternatives -- Recognizes other plans designed to achieve WQS may be more effective in the near term in some cases


WBPs is one type of a potential 303d Vision alternative

Watershed Based Plans → Roadmap for Water Quality Results in Nonpoint Source Program

- Watershed plans are not only the technical workplan guiding work related to:
 - Pollutant loads, sources, critical areas and practices that will have greatest impact on water quality
 - They are also a critical approach for engaging affected stakeholders and landowners in the process along the way. Basically, without local capacity/landowner engagement projects don't happen



 NPS Regional review minimum of I per year per state (per 319 guidelines)



Coordination between programs

- Regional NPS staff will continue to provide technical reviews of WBPs for 319 program and HQ NPS staff will coordinate with Regional NPS staff
- Regional 303(d) staff will take the lead for reviewing WBPs submitted as alternatives, and coordinate with HQ 303(d) staff, as appropriate
- Regional staff from <u>both</u> programs_to develop <u>their own</u> process at the regional level for coordinating reviews for NPS and 303d program purposes, such as:
 - Outline of steps to review plans by staff from both NPS and 303d programs (steps may be sequential or simultaneous);
 - Development of a joint work plan to identify annually plans that are likely submitted as alternative and therefore potentially warrant consideration by both programs.
