#### **Clean Water Act § 404 (b) (1)**

- Avoid, Minimize & Mitigate 404 (b) (1) Guidelines
  - applicant must first show that steps have been taken to avoid impacts to waters of the United States (WOTUS);
  - that potential impacts have been minimized;
  - and that compensation will be provided for all remaining unavoidable impacts.
- 1989 President George H. W. Bush established the policy of "no-net loss of wetlands" programmatic goal
- Agency interpretation expanded to "requirement" in every permit

### 2008 Compensatory Mitigation Rule (33 CFR PART 332)

- 2008, EPA and the U.S. Army Corps of Engineers expanded the 404(b)(1) Guidelines to include more comprehensive standards for compensatory mitigation
- Established new mitigation hierarchy
  - Off-site mitigation bank preference
  - In-lieu fee
  - On-site with some restrictions
- Shift from (1:1) quantified ratios to qualitative, replacing function and value in watershed

#### **Obama Administration Directives**

- Memorandum on Mitigating Impacts on Natural Resources From Development and Encouraging Related Private Investment, 80 Fed. Reg. 68743 (Nov. 3, 2015).
  - Required all federal agencies to strengthen mitigation policies and support private investment in restoration. The goals included:
    - At a minimum, create a no net loss of <u>land</u>, <u>water</u>, <u>wildlife</u> and <u>other ecological resources</u> from federal actions or permitting
    - If a resource is <u>irreplaceable</u>, impacts should be avoided altogether
  - Expanded "avoid, minimize, mitigate" CWA concepts to land and species
  - Created potential for significant expansion of "mitigation industry"
    - Credits
    - Banks
    - Trading

### **Trump Administration and New Congress Signal Change**

- Obama mitigation guidance revisited:
  - In February 2017, the House Committee on Natural Resources introduced H.R. Res. 60 to block USFW's compensatory mitigation policy
  - Trump March 28, 2017 EO "Promoting Energy Independence and Economic Growth" revoked Obama Mitigation Order
- March 29, 2017 Secretary Zinke signed Order 3349 "American Energy Independence" directing reexamination of the Department of the Interior's mitigation policies and practices



### **Trump Administration and New Congress Signal Change**

- Extent of federal jurisdiction revisited:
  - Trump EO, Feb. 28, 2017, Restoring the Rule of Law, Federalism, and Economic Growth by Reviewing the "Waters of the United States" Rule
  - EPA and Corps announced intent to review and rescind the Clean Water Rule. 82 Fed. Reg. 12532
     (Feb. 28, 2017)
  - Administrator Pruitt directs Scalia approach

- Administrator Pruitt encourages state-level regulation
  - NACEPT 2017 Report Assumable Waters
